

Terms of Sale Diplomatic Sales - Purchase Agreement

Leveringsvoorwaarden

1. All our transactions are governed by the general terms and conditions specified below, which are (unless stated otherwise) shared as schedule to this purchase agreement.

The General Terms and Conditions of sale and delivery of Diplomatic Sales Vehicles BMW Nederland B.V.

An English translation of the General Terms and Conditions of Sale and Delivery of Diplomatic Sales Vehicles BMW Nederland B.V. is at your disposal. The Dutch version of these general terms and conditions will prevail at all times.

Next to the General Terms and Conditions of Sale and Delivery of Diplomatic Sales Vehicles BMW Nederland B.V. the following terms and conditions will apply:

The BMW ConnectedDrive General Terms and Conditions which apply to any ConnectedDrive services in the vehicle. These terms and conditions will be shared when you create an BMW ID. This is your personal account to manage the ConnectedDrive services for your BMW. Please note that in case another language than the Dutch language is chosen, the ConnectedDrive terms and conditions for the Dutch market will prevail at all times and Dutch law will be applicable.

The General Provisions for the tyre insurance, which are shared as schedule to this purchase agreement (in Dutch).

If there are any discrepancies or differences in interpretation between the General Terms and Conditions of Sale and Delivery of Diplomatic Sales Vehicles BMW Nederland B.V. and aforesaid ConnectedDrive terms and conditions and/or the General Provisions for the tyre insurance, the General Terms and Conditions of Sale and Delivery of Diplomatic Sales Vehicles BMW Nederland B.V. will prevail.

2. Trade-in-vehicle arrangements do not form part of this purchase agreement.
3. Arrangements regarding accessories and aftersales do not form part of this purchase agreement.
4. The sale is conditional upon the purchased vehicle actually being or becoming available; if it is not available, more particularly but not only if it is part of a limited edition, the sale will be regarded as not having been concluded, without BMW Nederland B.V. being liable to pay damages or any form of compensation.
5. The sale is concluded when the authorised representatives of BMW Nederland B.V. approve the terms of this purchase agreement. Such approval will be deemed to have been granted unless you hear otherwise within a reasonable period of time.
6. If, in retrospect, it becomes apparent that you still owe VAT and/or BPM - despite the tax privileges you have reported that apply to you - the VAT and/or BPM owed will be added to the purchase price. In that case, the additional amount you owe will be calculated according to current laws and regulations. Changes to the VAT and BPM legislation can lead to different VAT and BPM amounts.

Payment method

On concluding the purchase agreement, you are obliged to pay an advance of 10% of the purchase price. You must pay the remainder of the purchase price to Dusseldorp Den Haag B.V., which handles invoicing on behalf of BMW Nederland B.V., on or before the date of delivery of the vehicle.
